### 3.2. Number of entrants accepted & classification

The organiser will accept a maximum of 120 entries. Entries can be rejected as per the MNASZ Regulation (Chapter 2, Art 6.7).

Accepted vehicles will be split into the following groups and classes:

#### Group N (Production class)

Class 4:	over 2000 cm <sup>3</sup>

#### Group A (including World Rally Cars [WRC])

Class 5:	up to (and including) 1400 cm <sup>3</sup>
Class 6:	over 1400 cm <sup>3</sup> up to (and including) 1600 cm <sup>3</sup>
Class 7:	over 1600 cm <sup>3</sup> up to (and including) 2000 cm <sup>3</sup>
Class 8:	over 2000 cm <sup>3</sup>

Group R cars will be classified according to the FIA Regulations art 4.2.

Group A Honda Civic's (FD2) with national homologisation (H-0109) can be entered into the Hungarian Open Rally Championship without FIA homologisation if complying with other Group A regulations.

The RSB prescribes the use of GPS tracking system for all National Rally Championship and Open Rally Championship entrants. The equipment leasing cost is 5900,- HUF (+VAT) which must be paid at the administrative check.

### 3.5. Terms of payment

The organiser can only consider the entry valid if the total amount has been settled and the receipt has been attached to the entry form, or the bank account credit transfer has been carried out. All documents / proofs must be sent by the deadline of submitting the entry or handed over by the Road Book issuing. The entry fee must be sent to the following address:

### 3.6. Refunds

Entry fees will be refunded according to the 2009 MNASZ prescriptions.

## 4. INSURANCE

Compulsory car insurance for the event: **12.000,- HUF**  
The above sum must be settled at the Administrative check to the MNASZ representative.

Only cars complying with the Hungarian law can take part at the event with valid insurance covering civil liability (foreign competitors with valid green card) and race insurance. The organiser will take out additional insurance for civil liability. This insurance will cover the car from the start of the rally and will cease at the end of the rally or at the moment of retirement or exclusion. Additional insurance for civil liability is established by contract No 190/2004 (VI. 8) between MNASZ and OTP-Garancia Biztosító RT insurance company (contract is available at the MNASZ secretariat).

The insurance will not cover the loss arising during the rally in the rally car or valuables inside the car, loss of other competitors, co-drivers or passengers in rally cars on the closed routes or roads closed from public or damage caused to the road surface without crashing the car.

## 5. ADVERTISING AND IDENTIFICATION

According to the 2009 MNASZ Regulations, Chapter 2, Art. 6.9.3.

### Identification:

Competitors will get two rally plates according FIA Prescriptions (MNASZ Prescriptions Chapter I., Art. 15) during the administrative check. These plates shall be affixed on the rally car according Appendix 4 of this document and must rest on the car during whole rally. If it is found at any time during the rally that one rally plate is missing, a cash penalty of 3000,- HUF will be imposed. In case both rally plates are missing, the crew will be excluded from the event.

Competitors will get competing numbers (according Chapter I., Art. 15 of the FIA Prescriptions and Chapter II., Art. 6.9.2 of the MNASZ Prescriptions) during the administrative check. These numbers shall be affixed on the rally car during whole rally. If it is found at any time during the rally that one competing number is missing a cash penalty of 4000,- Ft will be imposed. In case both numbers are missing, the crew will be excluded from the event.

## 8. RECONNAISSANCE

### 8.1. Registration procedure

During the Road book issuing, crews must fill-in a registration form and submit it. Every crew will receive an identification sticker from organiser, which must be affixed in the right upper part of the windscreen during the recce at all times. Missing sticker will mean failure to comply with the reconnaissance prescriptions. In the case the sticker is damaged or changing the recce car the team must ask the organiser for a new sticker. Competitors will also receive an identification card which must be accompanied by an ID photo (1nr each) supplied by the driver and co-driver. This card must be placed in the recce car during whole reconnaissance and shown to the marshals upon demand. The ID card is and A5 size card (heavy paper).

### 8.3. Special / National regulations

#### 8.3.1. Prescriptions for the recce cars:

- Series production vehicles
- Series production exhaust must be used, not exceeding the maximum noise level permitted by the Hungarian Law.
- Safety roll cage is permitted in accordance with FIA's International Sporting Code (Art 253.8.1-8.4)
- Two additional road-homologated headlamps are allowed
- Light intercom system is allowed without helmets

#### 8.3.2. Restriction on the direction of travel and number of allowed passages

Passage through the SS is permitted only in the direction described in the Road book. Every infringement will be penalised by the organiser.

8.3.3. Some special stages are private and forestry roads. Apart from the permitted recce these roads can not be used for any reason, starting from the publication of this document until the start of the rally. This prescription will be closely monitored by the road owners, the police and the organiser. The penalty for violating the above rule is start refusal.

Throughout the recce the crews must follow the Hungarian traffic rules and also every restrictions on the private roads. SS routes during the recce are not closed for traffic and it is important to keep in mind, that roads will be used also by other participants – cyclists, buses, forestry and agricultural machines. The recce schedule has to be followed.

**Every violation of the recce rules will be penalised. Penalties are ranging from cash penalty to the start refusal. The organiser will inform RSB (MNASZ) about penalisations.** Maximum cash penalty is 250 000,- HUF. **Upon the information provided by the organiser Stewards can also decide about time penalty for the crew.**

If an accident or loss of property occurred on the rally route or serious violation of the traffic rules occurred during the reconnaissance, the organiser is forced to refuse the start without refund of the entry fee and inform MNASZ about it. RSB (MNASZ) can also monitor the performance of the recce rules and decide about penalties.

The passage on the public road sections of the SS outside the recce is not considered as a violation, unless it's a competition built car. Any traffic offences on these routes act as violation of the recce rules after this document has been published and will be penalised as outlined.

The RSB can independently monitor the recce rules and penalise any offences separately.

The organiser must stress, there is a fire ban in place at all SS stages to avoid any large scale fire.

#### 8.4. Speed checks

The organiser will carry out speed checks during the recce with the following equipment: STALKER PROFESSIONAL SPORTS RADAR 34.7 GHz S.N.: SP78940 (FCC ID:IBQACMI001) and Kustom Pro-Lite (serial nr.: 200-2072-00).

Speed check will be carried out by sport referees (with a valid MNASZ ID card), members of the organising committee and MNASZ representatives.

Violation of the speed limits will be considered and penalised as violations against the recce rules (cash penalty, start refusal). The time penalties will be decided by the stewards.

The maximum speed on the SS routes (where no other speed limits are present) is 60km/h (=37mph)

Speeding fines:

up to 20%	5.000,- HUF
between 21-35%	40.000,- HUF
between 36-50%	80.000,- HUF
above 51%	start refusal

- HTP certificate of the Historic car or national documents produced by the ASN (for foreign competitors only)
- Homologisation card
- Certificates (roll cage, fuel tank, catalisator etc.)

10.1.1.2. Both crew members:

- Fireproof overall and undergarments complying with the regulations
- Helmets

10.1.1.3. Spare parts (turbos only) for marking and sealing

### 10.2. Schedule

#### According to the competition numbers:

The exact time will be submitted prior the Road Book issuing via an official publication.

Lateness will be penalised as the following:

Maximum fine for lateness: 10.000,- HUF.

Maximum lateness: 15 minutes, if exceeded the Stewards will penalise with start refusal.

## 11. RUNNING OF THE RALLY

The Official time during the event is as per the GPS signal or the DCF77; Mainflingen (South from Frankfurt) 77,5 kHz radio signal.

### 11.1. Ceremonial start, start of the rally:

 Prior commencing the Prologue all entrants will be introduced.

11.1.2. Competing numbers will be allocated in the following order:

1 <sup>st</sup> group	drivers with FIA A priority
2 <sup>nd</sup> group	drivers with FIA B priority
3 <sup>rd</sup> group	drivers with ASN priority and with gold licences
4 <sup>th</sup> group	other competitors
5 <sup>th</sup> group	competitors of Group H
6 <sup>th</sup> group	from 301 the CEZ and 'Iharos&Goller' Historic Rally Championship competitors

### 11.2. Changing time cards during the rally

The organiser will issue the time cards for both days during the administrative check. Time cards will be collected at TC regrouping – IN and at the last of the day (PF IN). There is an additional page for each section (as per the 2009 MNASZ regulations) for the sport referees and scrutineers to write their comments onto.

#### Starting procedure for the special stages

The crew are compulsory under the penalty of exclusion to have safety equipments during SS (from the start to the STOP) according FIA and national prescriptions (Appendix 5, Art.17). The crew must be prepared for start at the moment of arrival to the start line. SS starts will be given by an electronic countdown system. Sport referees will notify at 30s, 15s and 10s and then point at the digital starting equipment. From this point on the starting procedure continues where the countdown timer and the red and green signals will determine the moment of start. Photocell will record any start times (including early starts) and print it out.

### 11.3. Allowed early check-in

Early check-in is allowed for the following Time Controls:

### 11.4. Identification of the Officials

Control Chiefs:	red tabards
Marshals / Sport referees:	white tabards
Safety and SS Marshals:	blue and yellow tabards

### 11.5. Prologue / Super special stages

#### **Prologue description:**

The Prologue starts at 17.00 31-07-2009 at 'car park west' at Pécs Plaza. This is a regular part of the rally, however the result will not count towards the classification. Those crews who will not complete the Prologue could be penalised by the Stewards with a start refusal.

The Prologue can be only recce'd by foot as per the map issued at the Administrative check. The starting procedure will be as per the Marshals instructions, in descending numerical order. The start will be guided with a light device where the switch from red to green light will determine the start time. This will be recorded and printed on a timing device. In case there are matching results, the crew with a bigger competition numbers wins.

#### **Superspecial stage:**

No super special stage will be held.

### 11.6. Other special regulations

#### 11.7.1 Traffic rules

During the whole event the entrants must comply with the Hungarian traffic regulations without any fail.

Infringements will be penalised as following:

first occasion:	cash penalty (max. 20.000,- HUF)
second occasion:	5 minute time penalty
third occasion:	exclusion

The Race Director can apply a higher penalty then the above.

#### 11.7.2. Rules in case of an incident

**If a crew is involved in an accident in which a member of the public sustains physical injury, the driver or co-driver concerned must report this to the next radio point as specified in the road book and signed on the route.**

**If the accident happened at a place where spectators are or could be present, the driver must immediately stop and check if anybody was injured our was subject of any risk, if so the drivers must help. In case anyone obtained an injury, the nearest marshal and SS Chief must be informed while preserving the clues of the accident.**

**The crew may leave the place of the accident only with Police approval.**

**Any infringement of the above regulations will be penalised by The Stewards, penalty may go as far as exclusion. The national laws of the country in which the event is held must be followed in relation to the procedures outlined above.**

#### 11.7.3. Service Parks

##### Location

Day 1: Pécs Plaza, Pécs

Day 2: Pécs Plaza, Pécs

##### Entry for service vehicles

Day 1: 05.00-07.00, 01-08-2009

Day 2: 06.00-07.00, 02-08-2009

Service cars which entered the service park can leave at any time, however re-entry is forbidden except for Historic car's service vehicles. These vehicles can move freely.

Service cars may stay in the service park during the night. There will be a security patrol overnight, however the organiser can not take any responsibility for valuables left in the service park overnight.

##### Other regulations for the service park

Regulations for the service park is described in he FIA General Regulations. The service park is defined in the Road Book. In this area all kinds of repairs are allowed to be carried out. There are Time Controls at the entrance and exit for all rally cars. Apart from the rally cars only vehicles with 'service' identification are allowed in – 1nr per rally car (2nr for gold licence holders).

In the case a service car tries to enter the service park without service plate or with illegal service plate the relevant competitor will be penalised by the Stewards up to a maximum of 50 000,- HUF. In the case that service car enters the service park out of defined times the Stewards will penalise relevant competitor to pay a fine of 10 000,- HUF.

All team members must respect the rally regulations and marshals directions. The competitor is responsible for all team members during the rally.

The service vehicles are not official participants of the rally despite having a service plate. The event's insurance is not valid for them..

#### ***In the whole service park area***

***- Car washing is strictly forbidden due to environmental regulations***

***- At the service / repairing area each rally car must have a 3m\*5m sheeting underneath the car which is petrol and oil retardant.***

***- Each team must have at least a 150 litre waste bin to discharge any waste into.***

***- A minimum of 5kg fire extinguisher must be placed at the visible and easily accessible area at the service location.***

***- Catering is allowed at the service location, however open fire is forbidden.***

***- There won't be a refuelling zone at the end of the service park, all competitors can refuel at their service area complying with the relevant safety regulations.***

***The compliance with these regulations will be monitored by judges, the violations will be penalised by the Stewards.***

The organiser will establish refuelling zone during the race lengths. Refuelling at these zones is the competitor's sole responsibility!

The organiser will also establish tyre marking zone at the end of the service park.

The maximum allowed speed in the service area is 30km/h, in the refuelling zone max . 5km/h. Speeding will be penalised by the Stewards.

Additional crew „segítő” vehicles and Team Principals „csapatvezető” vehicles can not drive into the service park there will be a car park reserved for these vehicles immediately next to the service area.

#### **Regulations for auxiliary “segítő” cars**

„SEGÍTŐJÁRMŰ” can be purchased at the Administrative check or at the Rally HQ thereafter for 10.000,- HUF each.

Auxiliary „segítő” cars may enter the park area, which will be established next to the service park or to park areas near by SS at the road closing places.

Auxiliary „segítő” cars are not allowed to enter the service park. Any infringement of this prescription will be penalised by the Stewards with a fine of maximum of 300.000,- HUF.

#### **Service parks, prescriptions for servicing:**

Only relevant cars are eligible to enter the places reserved for the gold licence holders. It is forbidden for service cars and trailers to enter the places and roads in front of the Administrative checks and Scrutineering areas. Any infringement of this prescriptions will be penalised by fine of maximum of 100 000,- HUF.

All service activities are strictly forbidden between 31-07-2009 and 02-08-2009 on public areas. Observance of this rule will be monitored by the organiser in co-operation with Police and local authorities. Any infringement of this prescription will be penalised by the Stewards according Art. 152 and 153 FIA ISC.

Service cars (with „service“ plate) can, within the service park area, stay in places assigned for the relevant competition numbers.

The organiser will establish a refuelling zone on the road section of Day 1. Only 1 vehicle per rally car can enter the refuelling zone with a „tankoló zóna” plate. Vehicles with this plate can not enter the service park or car park reserved for the auxiliary „segítő” cars and team principal „csapatvezető” cars unless both plates are present on the vehicle.

*Any kind of commercial activity at the refuelling zone is strictly forbidden! Vehicles carrying out commercial, promotional and any other activities can only be stationed in a previously agreed location with the organiser. The teams can carry out promotional activities on their service area free of charge. Commercial activities, entry of additional vehicles and larger service area can be agreed with the organiser upon a separate commercial agreement.*

## 14. FINAL CHECKS AND PROTESTS

### 14.1. Final control

Location: Vörös Autóház (VW Dealership), 80 Megyeri Street, Pécs

The following people can represent the team at the final control:

- The competitor's representative – needs to provide an authorisation or the competitor's licence
- Particular crew
- Maximum 2nr mechanics of the particular crew

If the crew is not able to prove datas about parts in the homologation form after finish of the final control, the dismantling of the car must follow and Steward will decide about cash penalty 10 000,- HUF. Result of the infringement of this rule will be exclusion.

#### 14.2. Protest fees

Technical protest fee:	150.000,- HUF
General protest fee:	100.000,- HUF

In the case of the technical protest, if the protest requires the dismantling and the re-assembly of different parts of car, the claimant must pay an additional deposit according the decision of the Stewards. Deposit must be paid by the claimant. Protest will be refused if the deposit is not be paid.

The expenses incurred in the work and in the transport of the car shall be borne by the claimant if the protest is unfounded, or by the competitor against whom the protest is lodged if it is upheld.

If the protest is unfounded, and if the expenses incurred by the protest (scrutineering, transport, etc.) are higher than the amount of the deposit, the difference shall be borne by the claimant. Conversely, if the expenses are less, the difference shall be returned.

In the case of the technical protest the following persons can take part on the final control:

- People who perform the control
- Race Director
- Stewards,
- Scrutineer,
- Competitor against whom the protest is lodged and his 2 main mechanics
- Representative of the competitor against whom the protest is lodged (must present the competitor's licence or an authorisation)

#### 14.3. Appeal fees:

Cost for a national appeal fee (ASN):	100.000,- HUF
Cost for the secondary appeal fee:	250.000,- HUF

## 15. OTHER REGULATIONS

### 15.1 Procedure in case of an accident

If the accident happened at a place where spectators are or could be present, the driver must immediately stop and check if anybody was injured our was subject of any risk, if so the drivers must help. In case anyone obtained an injury, the nearest marshal and SS Chief must be informed while preserving the clues of the accident.

The crew may not continue the race and can only leave the place of the accident with Police approval.

#### Requirement in case of an accident, safety requirements

- 1) All participants must thoroughly know Art. 37 of the FIA Prescriptions.

- 2) When a red "SOS" sign is displayed, crews are mandatory to stop immediately to render assistance. Crews are compulsory to help to injured persons and make sure that safety services are mobilised as soon as possible.
  - 3) The first competing car which arrives at the scene of an accident must stop and inform next car about all the details.
  - 4) The next car must take the following information to next radio point (it can be also SS.
    - Competing number of the involved crew
    - Number of injured persons – members of crew or spectators and type of their injury
    - if any crew member or spectator is trapped in or outside the
    - Location of the accident, i.e. the closest road book junction or kilometre post
    - Any other vital information, i.e. fire, water ..
  - 5) The following cars must stop as well if the red "SOS" is displayed.
  - 6) All competitors stopped in the SS must place their red triangle at least 50 m before the stationery car even if the road is clear.
  - 7) Organiser First aid: +3630-896-5785
  - 8) In case of a retirement the crew must inform the
    - organiser: Phone number: +3630-554-6000
    - competitor's relations officer (Rádli József): Phone number: +3630-944-2323
  - 9) Competitors who retired from the rally must submit their time cards at the next TC as soon as possible.
- 15.2** Organiser has forbidden to the crews to perform doughnuts with car after the finish and in the Park fermé area!
- 15.3** Organiser allows to purchase additional Road books by the competitors. The price is 5000,- HUF (inc. VAT) which must be sent with the entry fee. These Road Books can be obtained at the same time as the other along with the receipt.
- 15.4** The team principal pass holders can obtain the team principal board „Csapatvezető” at the Administrative check. The team principal's document and licence should be presented at this time. TC & SS control areas can not be entered with the given board. These should be affixed to the top right hand corner of the windscreen. Parking is provided next to the service area.
- 15.5** The organiser allows to use tinted (both silver and colour) window films on side and rear windows and sunroofs during the event., given there are access holes where there inside of the car can be observed.
- 15.6** Damages caused in the rally cars by the impact of wild animals are excluded according Civil Code from 1959 year, No.: 345.
- 15.7** The organiser of the 42. ALLIANZ RALLYE retains the rights for all edition of written and electronic publications, including extended or shortened versions. Without the written permission of J-Group Fotoprint Kft no publications (extended or cut versions) can not be replicated, published in any way (written, electronic, or verbal media)
- 15.8** At the 42. ALLIANZ RALLYE all commercial rights (e.g. catering, commercial, advertising rights) are owned by J-Group Fotoprint Kft. Who will decide how to utilise these rights.
- 15.9** At the 42. ALLIANZ RALLYE media accreditations will be run in accordance with the 2009 RSB Media Committee Regulations.

To ensure all misunderstandings, small issues which can be solved by thorough explanation will not be passed onto the Stewards (e.g. questions regarding timekeeping, times etc), unless it is an official protest.

The CRO can not give out any information or can not behave in a way which would prompt protest on any participants' behalf.

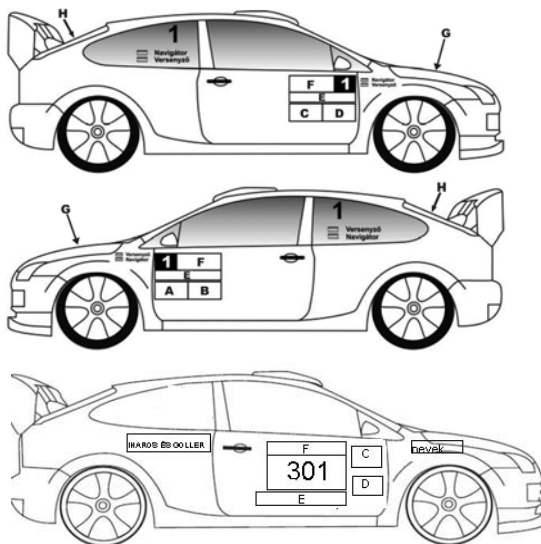
